STAFF REPORT

ITEM NUMBER 1- Adopt Resolution 15-01 Accepting the Election Results
BOARD MEETING OF JANUARY 7, 2015

A General District Election was held on Tuesday, November 4, 2014 and the "Statement of Votes Cast" in that election was prepared by the Monterey County Elections Department and delivered to the District on December 1, 2014.

There were three seats on the Board open for election, each for a four year term. The total number of ballots cast in the District at the General District Election was 60,066 and the three candidates with the highest number of votes were Vincent C. Ferrante, Antone "Tony" Leonardini and Andrew A. Amaral.

Attached to this report is Resolution No. 15-01 Accepting the Canvass of the November 4, 2014 Election. Staff recommends the Board adopt Resolution 15-01 and direct the Board Secretary to enter this Resolution in the official records of the District as a statement of the results of said General District Election.

RESOLUTION 15-01

A RESOLUTION OF THE MOSS LANDING HARBOR DISTRICT BOARD OF HARBOR COMMISSIONERS DECLARING CANVASS OF RETURNS AND RESULTS OF THE GENERAL DISTRICT ELECTION HELD ON NOVEMBER 4, 2014

WHEREAS, on April 23, 2014, the Board of Harbor Commissioners of the Moss Landing Harbor District adopted Resolution 14-02 calling for a General District Election to be held in the District on November 4, 2014; and

WHEREAS, said General District Election was held on Tuesday, November 4, 2014, in accordance with law, and the votes cast were received, canvassed and the returns ascertained, determined, and declared in all respects as required by law; and

WHEREAS, the "Statement of Votes Cast" in the November 4, 2014 election, prepared by the Monterey County Elections Department, was delivered to the District on December 1, 2014.

NOW THEREFORE, BE IT RESOLVED by the Board of Harbor Commissioners of the Moss Landing Harbor District as follows:

1. The total number of ballots cast in the District at said General District Election was 60,066.
2. The list of candidates nominated for the office of Harbor Commissioner to be filled at said General District Election, and the names of the candidates that were set forth in the petitions as required by law, and the number of votes cast in favor of each of the candidates were:

Vincent C. Ferrante	16,268
Antone "Tony" Leonardini	16,207
Andrew A. Amaral	14,738
Yohn Gideon	12,853

3. Vincent C. Ferrante, Antone "Tony" Leonardini and Andrew A. Amaral received the highest number of votes cast for the three seats open on the Board of Harbor Commissioners and were thereby elected Harbor Commissioners, each for the full term of four (4) years. The Board's Secretary is hereby authorized to sign and deliver thereto a Certificate of Election and to administer thereto (or delegate the responsibility therefore to any authorized individual) the Oath of Office prescribed in the Constitution of the State of California.
4. The Board's Secretary is hereby instructed to enter this Resolution in the official records of the District as a statement of the results of said General District Election.

ITEM NUMBER 03 – Nomination & Election of Board Officers BOARD MEETING OF JANUARY 7, 2015

There are 3 officer positions on the Board: President, Vice President and Secretary. The process for nominating and electing Board officers is EITHER someone nominates a slate of officers so all positions can be voted on by a single motion, OR nominations for each individual office are made. There can be more than one nomination for each office.

In either event, following the nomination(s) for the slate or respective offices, another motion must be made to close the nominations. First, a roll call vote is taken on the motion to close the nominations; then a roll call vote is taken to vote on the nomination(s).

At this time, the nominations are open for the positions of President, Vice President and Secretary.
